This chart illustrates how much a patient would have to consume of a variety of omega-3 sources to compare to 1 serving of two leading Nordic Naturals omega-3s.


Fish vs Flax and Krill

Omega-3 fatty acids fall into two major categories: marine derived (fish, algae, krill) and plant derived (flax, chia). Flax is a source of alpha-linolenic acid (ALA) with low conversion to long-chain EPA and DHA. **Research shows that even under optimal lifestyle and health conditions, less than 5% of ALA converts to EPA, and just 1% converts to DHA**.

Although krill oil is a marine-based source of omega-3s, very few human clinical studies have been completed on it. In addition to a lack of research, potency is a key consideration. Krill is low in EPA and DHA. A recent study showed a serving of concentrated fish oil to be 382% more effective in increasing omega-3 blood levels than a serving of krill oil.⁴

Molecular Form Matters

Research continues to show that fish oil in the triglyceride molecular form offers a significant absorption benefit over fish oil in the ethyl ester form. When manufactured according to international quality standards, fish oil delivered in the triglyceride form has a proven record of potency, efficacy, purity, and sustainability, and is backed by substantial research. High-quality algae oil is also a safe, effective source of the omega-3 essential fatty acids EPA and DHA.


